## Public Time.

A citizen returned for an update on street lights: Fods indicated that Xcel Energy is working through their process.

A business owner had concerns about trailers/RV's parking on commercial lots. It was noted that the trailers belonged to the businesses that owned the lots in question and no violations were involved.

Police Report. There was no Deputy present. There are concerns about underage, non-licensed drivers operating golf carts on City streets.

Maintenance Update. Fods indicated that the maintenance staff was busy working on the parks in preparation for Baltic River Park Days and upcoming tournaments.

City Hall Update. Hoefert gave the financial report, confirmed the planning retreat for July 30 at Inspiration Hills and reminded the Council she and City Administrator Fods would be at Budget Training on July 23 in Sioux Falls. Deputy Finance Officer Faith will be in the office those days until 2 p.m. It was also noted that there were not enough registrations for swimming lessons in Dell Rapids; therefore no group lessons will be provided.

Attorney Remarks. City Attorney Hughes had no remarks at the time.

## Business.

Grunewaldt made a motion to approve a Temporary Malt Beverage License for the Baltic Lounge and Cantina for the dates of July 17 – July 19 for use during Baltic River Park Days at specified locations. Jenks seconded, all Ayes.

At 8:00 PM Drayer made a motion to go into Executive Session to discuss business and to communicate with City Attorney Hughes. Grunewaldt seconded. All Ayes.

At 8:30 PM Council President Whiting declared the City Council to be out of Executive Session. No motions were made and no actions were taken.
